TO CLASS MEMBERS:

Further to the Notice to Class that was sent out yesterday, as there seems to be some confusion as to what the San Diego Funds are, I am responding to the many many e-mails I've received with one response.

The San Diego Funds are a group of just over 300 cheques / bank drafts which were seized back in 2004 by the FBI. A Receiver in San Diego has already returned funds to people listed in the Schedule "C" attached. When we say "Traceable Claims" we mean people who can provide a bank draft that matches one of the seized cheques / bank drafts. Schedule "A" to the Notice is a list of people who have already provided me with a bank draft number that matches the list we have. Schedule "B" to the Notice is a list of people, or last names that appear on the list that also appear in our list of class members who have not provided a copy of their bank draft. If your name does not appear on one of these lists, it is unlikely that you have a traceable claim, HOWEVER, there is a possibility, so if you have any inkling that your money was sent to San Diego, please provide me with copies of the cheques / bank drafts used to make your investment, and we will compare them to the list of drafts seized to ensure they are not traceable.

Of the 300 plus cheques, there were several that were in the names of Customer Care Specialists (CCS's). The other way that a claim can be traceable is if you can show that the money you paid to one of those CCS's was pooled with other investors and then sent to San Diego by your CCS. This will obviously be a much harder claim to prove, but if you can obtain sufficient evidence from your CCS (i.e. their deposit slips, tracking records showing which funds were sent where) to meet the test of traceability, then those claims will be considered by the court.

I am well aware that many of you have already provided me with copies of your documentation. Unfortunately, with over 900 class members, it is not possible for me to go through all of the documentation and search to see if bank drafts were provided and if they match one of the drafts in the list. Therefore, after considering the information above, if you feel you may have a traceable claim, we are asking that you provide those Bank Drafts to us. **ONLY BANK DRAFTS** can be used to trace your claim, no other documentation is necessary unless you believe you can show a traceable claim in the <u>second</u> category. If you have provided me with your only copy, please e-mail me and in that instance I will locate your documents.

If you do not have a traceable claim to the San Diego funds, you are not "out of luck", so to speak, in getting funds back. We have made various settlements which have not been disbursed, and we anticipate that not all of the San Diego funds will be traced, and the remainder of those funds will be pooled and distributed to the entire class upon conclusion of this matter.
